



Physical Therapist Assistant Program Frequently Asked Questions (FAQ's)

Where will clinical rotations occur?

With the increasing number of Physical Therapist and Physical Therapist Assistant programs throughout the United States, there is a greater demand on the clinical sites for student placement. For this reason and in order to ensure quality clinical education, proximity to the clinical site cannot be guaranteed. Regardless of distance to the clinical site, it is the responsibility of the student to complete and fund their own travel and any necessary housing arrangements.

What are the hours for the clinical rotations?

Clinical rotation hours vary. Students will be expected to be available to be in the clinic Monday thru Friday. Hours may begin as early as 7 am and may last as late as 8 pm. Students will be in the clinic the hours their Clinical Instructor works. Occasional weekend work may be required.

What is observation?

Observation hours are not required for admittance to the PTA program. An individual is encouraged to observe/shadow at a clinic or healthcare facility to learn about the field of physical therapy and what a typical day might be like in this profession. To observe, you simply contact a facility and request to observe a PT or PTA indicating that you are interested in the field of PT and would like to learn more about the profession.

When do I apply for the criminal background check?

Background checks are not performed until after the applicant has been accepted into the program. This is a requirement for clinical rotations. Some clinical sites may not accept students with criminal records. If an applicant has a criminal background he or she may not qualify for licensure. What are my chances of getting into the program?

A competitive selection process is used to choose students for each upcoming class. The class size is limited (18 students per year) as it is in all PTA schools; therefore, all candidates are encouraged to apply to more than one school to increase their chances for selection.

How long does it take to complete the program?

The program can be completed in four semesters. Prerequisite work, before the 4 semester program, can be completed in two semesters. The program is intense and very much like a full time job.

How physical is the job?

The duties of a PTA are typically very physical in nature. Pushing, kneeling, lifting and walking are routine activities. See the [Essential Skills](#) for further details.

Students must be cleared by a physician to attend clinical and have all immunizations up to date. Additionally, students must have a current PPD test.

What prerequisite classes do I need to complete before submitting my application?

In addition to the above courses, students are strongly encouraged to complete ALHS 1090 to earn extra points in the admissions process.

**Please note that exemption testing may exist for students who have met the Math requirements, but after the three year minimum. How do I know what will transfer from my previous coursework I have completed in college?

You have to apply to Lanier Technical College and have your transcripts evaluated for transfer course equivalency. Have your present or past college send your transcripts to Lanier Technical College when you apply to the College, which is separate from the PTA Admission Application. Which campus offers Lanier Technical College's PTA program?

The PTA program is offered on the Forsyth Campus. Pre-requisite coursework may be completed at any campus.

Do I have to apply for Admission to Lanier Technical College and the PTA program? Are these separate?

Yes, you must apply for Admission to Lanier Technical College and declare PTA as intended course of study. This must be completed in the semester prior to applying for Admissions to the program (i.e. Summer Semester). Every year in July, the PTA Application is posted on the website and is due the 2nd Friday in August of each application year.
